

Luiz Carlos Trabuco Cappi

Born on October 6, 1951, in Marília, São Paulo. Graduated from the School of Philosophy, Sciences and Literature of São Paulo. He began his career at Banco Bradesco S.A. in April 1969. He held all positions of the hierarchical scale of a bank. In January 1984 he was elected a Department Director, in March 1998 a Managing Officer, and in March 1999 an Executive Vice President.

On March 10, 2009 he became Chief Executive Officer of the Board of Directors of the Bank, holding cumulatively, as from this date, the position of Member of the Board of Directors.

He is also CEO of the others companies of Bradesco Organization, Member of the Managing Body and Managing Director of Fundação Bradesco, and Member of the Board of Directors and Managing Director of the Foundation Institute for Digestive System and Nutrition Diseases (FIMADEN).

Besides these activities, he is a Sitting Member of the Board of Directors of the Brazilian Federation of Bank Association (FEBRABAN), Sitting Member of the Board of Directors of Fundo Garantidor de Créditos – FGC, Member of Honorable Council ANSP – National Academy of Insurance and Plan Association, Member of the Consultive Council of APTS -São Paulo Association of Insurance Technicians and Sitting Member of the Association Internationale pour l'Etude de l'Economie de l'Assurance – Association de Genève, Geneva, Switzerland.

He was Chief Executive Officer of Bradesco Seguros S.A from March 2003 to March 2009, in which he held the position of Member of the Board of Directors from March 1999 to March 2005. He was Sector Officer of ADVB - Brazilian Association of Sales Managers, Chief Executive Officer of ANAPP - National Private Pension Plan Association, of the Supplementary Health National Federation – FENASAÚDE and of the Marketing and Capitation Committee of the Brazilian Association of Home Loans and Savings Entities - ABECIP, Member of the Managing Council of the Brazilian Association of Publicly-Held Companies – ABRASCA, of Rio de Janeiro Commercial Association and of the Supplementary Health Studies Institute – IESS, Member of the Board of Directors of the Companhia Siderúrgica Belgo-Mineira, Marketing Sector Officer and Member of the National Council of Bank Ethics (CONEB) of the Brazilian Federation of Bank Association (FEBRABAN), Member of the International Affairs Committee of the Superintendence of Private Insurance (SUSEP) and Member of the Superior Board and Vice-President of the Confederação Nacional das Empresas de Seguros Gerais, Previdência Privada e Vida, Saúde Suplementar e Capitalização – CNSeg and its Sitting Representative in National Confederation of the Financial System - CONSIF.
